Sgt-at-Arms Civils made a motion to cast one ballot for the election today for all the unopposed positions (none of the positions are opposed) 2<sup>nd</sup> by 2VC Bates, one nay and one abstention, motion carried. Adjutant McIsaac casted the ballot for each position as stated and nominated. The new CMDR is CMDR (elect)McIsaac, the 1VC is incumbent 1VC Dr Blue, 2VC is incumbent 2VC Bates, 3VC is incumbent 3VC Miller-Williams, Sgt-at-Arms is Sgt-at-Arms (elect) Profit.
