### A RESOLUTION OF THE JESSE CLIPPER AMERICAN LEGION POST 430 APPROVING THE STRATEGIC PLAN FOR LAND ACQUISITION AND NEW POST BUILDING

**WHEREAS**, the Jesse Clipper American Legion Post 430 is committed to serving veterans, their families, and the community with excellence and integrity; and

**WHEREAS**, the leadership of Post 430 has developed a comprehensive Strategic Plan outlining objectives for the acquisition of suitable land and the construction of a new, modern building to support the Post's mission; and

**WHEREAS**, the Strategic Plan includes clear goals, a financial plan, stakeholder engagement, risk management strategies, and a detailed implementation timeline to ensure the success of the project; and

**WHEREAS**, the members of Jesse Clipper American Legion Post 430 recognize the importance of this initiative for the future growth, sustainability, and impact of the Post;

#### **NOW, THEREFORE, BE IT RESOLVED THAT:**

1. The membership of Jesse Clipper American Legion Post 430 formally approves and adopts the Strategic Plan for Land Acquisition and New Building Construction as presented.
2. The Post leadership is authorized to proceed with actions necessary to execute the Strategic Plan, including:
  - Identifying and securing funding sources (grants, donations, sponsorships, capital campaigns, and loans);

4. Regular progress reports shall be provided to the membership to ensure transparency, accountability, and member engagement throughout the project.
5. The Post reaffirms its commitment to honoring the legacy of Jesse Clipper and supporting veterans through this strategic investment in the future.
